## Information obligation with regard to submitting the application for admission to school

Administrator of Personal Data (APD) included in the application for child's admission to school is Zespół Szkół EKOLA Fundacji Oświatowej EKOLA, ul. Tadeusza Zielińskiego 56, 53-534 Wrocław.

Personal data included in the application are processed only to the extent necessary for consideration of the application, and subsequently, in case of positive outcome of the application process, for conclusion and implementation of the Agreement for Child's Education. Personal data are processed in accordance with the Regulation of the European Parliament and of the Council (EU) 2016/67 of 27 April 2016 on the protection of natural persons in relation to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (general data protection regulation), as well as the Law on School Education.

Providing personal data is necessary to consider the application and conduct the application process, and subsequently for conclusion and implementation of the Agreement for Child's Education. In case data are not provided, the application cannot be considered. In case of negative outcome of the application process, the personal data provided in the present application shall not be kept on school record. In case of positive outcome of the application process, the personal data provided in the present application as well as in the Agreement for Child's Education shall be kept on school record for the period of 20 years since termination of the Agreement.

You are entitled to access your data as well as the child's data, correct, delete or restrict them as well as object to their processing, require to cease to process or transfer them. If you find data processing to violate applicable regulations, you can file a complaint at the supervisory authority, i.e. President of Personal Data Protection Office, within the scope of personal data processing control.
